GENERAL INFORMATION

Growthful Pre-Emerge MAX SOIL AMENDMENT (Growthful Pre-Emerge MAX) is a liquid additive that will solubilize iron, calcium, and potassium in the soil increasing the availability of these nutrients to the plants. It is an additive to your normal nutrient regime and should NOT be used as a replacement for nutrients. Its NPK values are 0-0-0.

DIRECTIONS FOR USE:

For application, compatibility and safety use on all crops as instructed by this label:

Burndown application: Dilute 1 gallon of **Growthful Pre-Emerge MAX** in 10 gallons of water and apply to soil prior to sprouting of plant. The target application rate is 1 gallon of **Growthful Pre-Emerge MAX** per acre.

In Furrow application: Dilute 8 oz of **Growthful Pre-Emerge MAX** in 3 gallons of water per acre on 30" rows. For fields with 15" rows, dilute 16 oz **Growthful Pre-Emerge MAX** in 6 gallons of water per acre.

Make 1 application per growing season. Soil type, nutrient brand, irrigation schedule, and crop types can affect **Growthful Pre-Emerge MAX** results. Consult your Aqueus representative for recommended rates and timings.

COMPATIBILITY/SAFETY: Aqueus makes no claims as to **Growthful Pre-Emerge MAX's** compatibility with any particular crop and/or its use in conjunction with other chemicals/materials on any particular crop or its safety when used with other chemicals. **Growthful Pre-Emerge MAX** should be applied alone in water.
